The agency shall ensure that the persons deployed in the Kendriya Vidyalaya No1, Kankarbagh, Patna should not have any adverse police records/criminal cases against them the agency should make adequate enquiries about the character and antecedents of the person who they are deploying. The service provider will ensure verification of character and antecedents of the each personnel before their deployment after investigation by the local police, collecting proof of Identity like driving license, bank account details, previous work experience, proof of residence and recent photograph and a certificate to this effect, needs to be submitted to the Kendriya Vidyalaya No1, Kankarbagh, Patna.
